Legal education in the Irkutsk national research technical University counts its history since 1993, the code was created by the Department of legal disciplines. Since 2011 training of lawyers in the undergraduate exercises 4 chairs along three profiles: criminal law, civil law, state law. Legal education in the Irkutsk national research technical University is a classical combination of fundamental theoretical training with practice; highly qualified teaching staff; individual approach to each student; implementation of educational programs of additional vocational training on the basis of the Center of electoral technologies, Legal clinics, etc.; use of modern information and communication technologies; the availability of libraries, including electronic and resource center; organization of cultural and sports life of students; a combination of teaching and research activities of students. The Department of criminal law disciplines, provides training for lawyers in criminal legal profile to work in the judiciary, the Prosecutor's office, investigative Committee, police, customs, tax authorities, the bailiffs, the legal profession.

Theoretical knowledge in the disciplines students will be tested in a specially equipped and equipped with modern means of forensic laboratories Department and the Interregional center of forensic expertise of the Irkutsk national research technical University, on the virtual polygons. Students have the opportunity to understand and appreciate the complexity and importance of the search cognitive activity of the investigator and the research work of a forensic expert. In the training Hall of court sessions the students trying on the role of the various actors, play out the business game "Trial by jury" "trial court," gain experience drafting legal documents, experience in public speaking.

Under civil profile prepared lawyers in court, arbitration court, notaries, lawyers, prosecutors, social welfare authorities, trade

"Electoral law of the Russian Federation" etc., as well as across multiple disciplines.

Graduates can work in state and municipal authorities, including the legal services of these bodies, in various public institutions, including supporting the law-making process.
